We will acquire the works published by Edicions Bellaterra with the intention of giving continuity to the existing project.

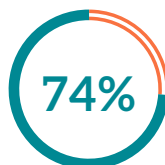

CO-OP SECURITIES

[What's a Co-op security?]

A Co-op security is a long-term loan that intends to raise the necessary funds in order to develop or expand a project.

[Conditions]

- 300 participative securities worth 1000 euros each.
- The capital invested will be returned after 5 years, with the possibility of extending it annually. This refund will depend on the cooperative's good functioning.
- Securities will be available from the 1st of October to the 31st of December 2019.
- 1,50% annual return.
- Annual interest payment.
- Save money while investing in culture.
- Responsible investment.

[Guarantee]

- 20% contribution by the cooperative.
- 6% contribution by the cooperative working members.
- 8 years of solvency and experience in the sector.
- We have never been in need of bank funding.

[Types]

1. If you contribute **1000 euros** you will be able to **choose** between:
 - a. A 1,5 % annual return.
 - b. Annual subscription to Catarsi Magazin.
2. If you contribute **2000 to 5000 euros** you will be able to **choose** from:
 - a. A 1,5 % annual return.
 - b. A voucher worth three books published by Tigre de Paper and an annual subscription to Catarsi Magazin.
3. Contributing over 6000 you will receive:
 - A 1,5 % annual return.
 - An annual subscription to Tigre de Paper.
 - An annual subscription to Catarsi Magazin.
